RESOLUTION NO. 03-108

1 **WHEREAS, pursuant to Legislative Council Resolution No. 2000-515, the Office of the Chairman**  
2 **is presently operating KOHN-FM under a grant from the U.S. Department of**  
3 **Commerce, National Telecommunications and Information Administration and a**  
4 **budget set aside from the Nation's savings account; and**

5 **WHEREAS, any amendments affecting the funding or funding levels of the grant shall be**  
6 **submitted for review and approval by the Legislative Council; and**

7 **WHEREAS, the KOHN-FM program has submitted the attached Amendment No. 1, as attached**  
8 **and incorporated by this reference; and**


9 **WHEREAS, under Amendment No. 1, the utility line item is decreased under account (01-3031) by**  
10 **\$15,243 and this amount is transferred to the capital project account (50-3030) for the**  
11 **purposes of funding unexpected costs in the building of the KOHN-FM studios; and**

12 **WHEREAS, the Budget and Finance Committee of the Legislative Council have reviewed and**  
13 **approved Amendment No. 1 to the KOHN-FM budget for Fiscal Year 2003.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the**  
15 **Amendment No. 1 to the KOHN-FM budgets (Account Nos. 01-3031 and 50-3030) as**  
16 **attached and incorporated by this reference are hereby approved and authorized.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04<sup>TH</sup> Day**  
18 **of MARCH, 2003 at a meeting at which a quorum was present with a vote of 2,256.8 FOR; -0-**  
19 **AGAINST; -0- NOT VOTING; and 160.7 [03] ABSENT, pursuant to the powers vested in the Council by**  
20 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
21 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
22 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
23 **18, 1934 (48 Stat. 984).**
