

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Support for a Third Continuation Authorization for Pisinemo District Home
Renovation Supplement Budget)**

RESOLUTION NO. 03-118

1 **WHEREAS, at a regularly scheduled session of the Legislative Council, Pisinemo District did**
2 **present a proposal for a third and final continuation for another three months of the**
3 **Home Renovation Budget under the \$500,000 Supplemental monies; and**

4 **WHEREAS, the proposal is requesting a third continuation on the \$500,000 supplement to fund**
5 **the Home Renovation Project utilizing projected savings the District will have by the**
6 **end of March 31, 2003; and**

7 **WHEREAS, the total amount of funding required for the Home Renovation Project to be extended**
8 **for another three months ending on June 30, 2003 is \$79,692.18.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council finds there is**
10 **sufficient monies available to continue Pisinemo District's Home Renovation Project**
11 **for another three months in the amount of \$79,692.18 for salaries, fringe benefits,**
12 **and an operational budget.**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH Day**
14 **of MARCH, 2003 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**
15 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
16 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
17 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
18 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
19 **18, 1934 (48 Stat. 984).**
