

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval to amend the Gu-Vo District FY 01 Supplement Budget)**

**RESOLUTION NO. 03-122**

1 **WHEREAS, the Gu-Vo District Governing Council did convene for their regular council meeting**  
2 **on February 22, 2003 to discuss the Administrative office request for a budget**  
3 **modification; and**

4 **WHEREAS, the District Administration did meet with the District's Budget & Finance Committee**  
5 **to modify funds within the District's Supplement Budget; and**

6 **WHEREAS, the Gu-Vo District Administration found it necessary to include Capital Equipment**  
7 **line item for the purchase of radios/electronic equipment for the Administrative**  
8 **Security; and**

9 **WHEREAS, the Administration's FY 2001 Supplement Budget does have funds available for this**  
10 **line item; and**

11 **WHEREAS, the Gu-Vo District Governing Council feels that it is in the best interest of the District**  
12 **to amend the budget to include line item Capital Equipment to the Administrative**  
13 **FY01 Supplement Budget.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council**  
15 **hereby approves the amended and modified Gu-Vo District FY 2001 Supplemental**  
16 **Budget as attached, which shall include line item 750, Capital Equipment.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup> Day**  
18 **of MARCH, 2003 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**  
19 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
20 **Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
21 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
22 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
23 **18, 1934 (48 Stat. 984).**




