

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Setting March 20, 2003 Special Session to Approve FY 2003 P.L. 93-638 Budgets)**

**LEGISLATIVE ORDER NO. 03-130**

1 **WHEREAS, "The Legislative Council may, by majority vote, call for a Special Session to be held for**  
2 **the purposes of completing unfinished agenda, addressing issues requiring an**  
3 **Executive Session, and/or reviewing special reports from Committees, Programs or**  
4 **other sources." (Legislative Rules, Article I, Section 1.D.1.); and**

5 **WHEREAS, the Council set a special session for March 12, 2003 to approve FY 2003 P.L. 93-638**  
6 **budgets for the continued operation of programs under the Nation's modified P.L. 93-**  
7 **638 Master Contract; and**


8 **WHEREAS, there has been a delay in executing the Nation's modified P.L. 93-638 Master Contract;**  
9 **and**

10 **WHEREAS, it is necessary to set a special session for March 20, 2003 to approve FY 2003 P.L. 93-**  
11 **638 budgets for the continued operation of programs under the Nation's modified**  
12 **P.L. 93-638 Master Contract.**


13 **NOW THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby**  
14 **sets a Special Session for March 20, 2003 to approve FY 2003 P.L. 93-638 budgets.**

15 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup> Day of**  
16 **MARCH, 2003 at a meeting at which a quorum was present with a vote of 2,141.45 FOR; -0- AGAINST;**  
17 **115.35 NOT VOTING; and 160.7 [03] ABSENT, pursuant to the powers vested in the Council by**  
18 **Section 1 (a) and 1(d) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**  
19 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
21 **18, 1934 (48 Stat. 984).**
