3 **foregoing applications for enrollment in accordance with Section 1(a) of Article**
4 **XIII of the Enrollment Ordinance; give notice of this Council's determination in**
5 **accordance with Section 2 of Article XIII of the Enrollment Ordinance; and place**
6 **the names of each applicant upon the membership roll of the Tohono O'odham**
7 **Nation in accordance with Sections 2 and 3 of Article X of the Enrollment**
8 **Ordinance.**

9 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 07TH Day**
10 **of APRIL, 2003 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;**
11 **-0- NOT VOTING; and [0] ABSENT, pursuant to the powers vested in the Council by Section 1 of**
12 **Article II and Section 1(h) of Article VI of the Constitution of the Tohono O'Odham Nation,**
13 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**
14 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
15 **Act of June 18, 1934 (48 Stat. 984).**


