

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Employment & Training Program PY 02/FY 03 Budget Modification
#1/Comprehensive Service Plan/State Contracts Amendment)

RESOLUTION NO. 03-162

1 WHEREAS, the Department of Labor - Comprehensive Service Plan and Budget has been
2 developed with current allocation in the amount of \$473,409.00 beginning July 1, 2002
3 and ending June 30, 2005; and

4 WHEREAS, the Department of Labor - Supplemental Youth Service Plan and Budget has been
5 developed with current allocation in the amount of \$ 172,404.00 beginning June 1,
6 2002 and ending June 30, 2005; and

7 WHEREAS, the Arizona of Economic Security - Adult and Youth PY 02 and FY 03 Budgets and
8 Contract amendment #1 have been reduced to the final allocation in the amount of \$
9 255,869.00 which is a reduction of \$4,110.00; and

10 WHEREAS, the Department of Health and Human Services Budget has been developed in the
11 amount of \$ 150,868.00 beginning July 1, 2002 and extending to June 30, 2004; and

12 WHEREAS ,the original resolution to approve the budgets was 02-210 TOLC, and one case
13 manager position has been eliminated.

14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
15 approve the Employment & Training Budgets/Comprehensive Service Plan and Budget
16 Modification #1 PY 2002 in the amount of \$645,813.00 Department of Health and
17 Human Services Native Employment Works Budget PY 2002 in the amount of
18 \$150,868.00 and Arizona Department of Economic Security State Contract Amendment
19 #1 PY02/FY03 in the amount of \$255,869.00 in the combined amount of \$ 1,052,550.00.

20 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
21 Nation's Officials, to wit; the Chairman is hereby authorized to negotiate and execute
22 the contracts and plans, provided however, that any amendment affecting the funding
23 or funding levels of this contract shall be submitted for further prior approval by this
24 Council.

25 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH. Day
26 of APRIL, 2003 at a meeting at which a quorum was present with a vote of 2,162.65 FOR; -0-
27 AGAINST; 254.85 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by
28 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
29 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
30 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
31 Stat. 984).


