RESOLUTION NO. 03-165

1 WHEREAS, the funding amount for the State of Arizona, Department of Economic Security, - Adult  
2 Program PY 2001 is \$ 31,077.00; and

3 WHEREAS, this budget modification creates line numbers for travel expenses for additional  
4 travel needs during the re-authorization of the Workforce Investment Act and client  
5 support to provide quality services for clients seeking long-term employment; and


6 WHEREAS, this budget will expire on June 30, 2003.

7 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby  
8 approve the State of Arizona - Department of Economic Security - Adult Program PY  
9 2001 Budget Modification #1 in the amount of \$31,077.00.

10 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham  
11 Nation's Officials, to wit; the Chairman is hereby authorized to negotiate and execute  
12 the contract, provided however, that any amendment affecting the funding or funding  
13 levels of this contract shall be submitted for further prior approval by this Council.

14 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup> Day  
15 of APRIL, 2003 at a meeting at which a quorum was present with a vote of 2,256.8 FOR; -0- AGAINST;  
16 160.7 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (f)  
17 of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
18 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
19 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


