

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of the Tohono O'odham Nation Employment & Training - State of**  
**Arizona - FY 2002 Admin Adult Budget Modification #1)**

RESOLUTION NO. 03-167

1 WHEREAS, the funding amount for the State of Arizona, Department of Economic Security, -  
2 Administrative Adult Budget Fiscal Year 2002 is \$7,231.00; and

3 WHEREAS, this budget modification creates line number for travel expense for additional travel  
4 needs during the re-authorization of the Workforce Investment Act; and

5 WHEREAS, this budget will expire on June 30, 2003.

6 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby  
7 approve the State of Arizona - Department of Economic Security - Administrative Adult  
8 Fiscal Year 2002 Budget Modification #1 in the amount of \$7,231.00.

9 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham  
10 Nation's Officials, to wit; the Chairman is hereby authorized to negotiate and execute  
11 the contract, provided however, that any amendment affecting the funding or funding  
12 levels of this contract shall be submitted for further prior approval by this Council.

13 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup> Day  
14 of APRIL, 2003 at a meeting at which a quorum was present with a vote of 2,256.8 FOR; -0- AGAINST;  
15 160.7 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (f)  
16 of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
17 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
18 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




