RESOLUTION NO. 03-169

1 WHEREAS, the funding amount for the Department of Labor WIA PY 2001 Comprehensive Service  
2 Program Budget is \$ 468,151.00; and


3 WHEREAS, the program adjusted the budgets to reflect additional line items of client support to  
4 assist clients towards employment.

5 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby  
6 approve the Department of Labor WIA PY 2001 - Comprehensive Service Program  
7 Budget Modification #1 authorized for expenditure from July 1, 2001 until June 30,  
8 2004 in the amount of \$ 468,151.00.

9 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham  
10 Nation's Officials, to wit; the Chairman is hereby authorized to negotiate and execute  
11 the contract, provided however, that any amendment affecting the funding or funding  
12 levels of this contract shall be submitted for further prior approval by this Council.


13 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup> Day  
14 of APRIL, 2003 at a meeting at which a quorum was present with a vote of 2,256.8 FOR; -0- AGAINST;  
15 160.7 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (f)  
16 of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
17 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
18 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


