

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Supporting the Chukut Kuk District Request to Remove the Beacon Light at  
San Miguel Gate)**

**RESOLUTION NO. 03-178**

1 **WHEREAS, at the regular March 2003 meeting of the Chukut Kuk District Council, the New Fields**  
2 **Community, through their Representatives requested support from Chukut Kuk**  
3 **District Council in their efforts to get the beacon light located at the San Miguel Gate**  
4 **removed; and**

5 **WHEREAS, the O'odham members from communities north and south of the border expressed**  
6 **concern that the beacon light was placed at the San Miguel Gate without their input**  
7 **and it does not serve a purpose other than to attract more illegal aliens and criminal**  
8 **activity through O'odham communities; and**


9 **WHEREAS, the Chukut Kuk District Council did enact Resolution No. 2003-10 in support of the**  
10 **New Fields Community.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
12 **supports the removal of the beacon light erected at the San Miguel Gate without**  
13 **input from or consultation with the Tohono O'odham Nation.**

14 **BE IT FINALLY RESOLVED that the Chairman of the Nation is hereby authorized and directed to**  
15 **investigate the beacon light and take all necessary actions to have the light removed.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup> Day**  
17 **of APRIL, 2003 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;**  
18 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**  
19 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
20 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
21 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


