


RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval to Amend the Gu-Vo District FY 02/03 Budget)

RESOLUTION NO. 03-179


1 **WHEREAS, the Gu-Vo District Governing Council did convene for their regular District meeting**
2 **on the 22nd of March 2003 to discuss the Administrative office request for a budget**
3 **modification; and**
4 **WHEREAS, the District Administration did meet with the District's Budget & Finance Committee**
5 **to modify funds within the District's Supplement Budget; and**
6 **WHEREAS, the Gu-Vo District Administration found it necessary to include Capital Equipment**
7 **line item for the purchase of a facsimile machine for the Administrative office; and**
8 **WHEREAS, the Administration's FY 02/03 Budget does have funds available for this line item;**
9 **and**
10 **WHEREAS, the Gu-Vo District Governing Council feel that it is in the best interest of the District**
11 **to amend the budget to include line item Capital Equipment to the Administrative**
12 **FY 02/03 Budget.**
13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
14 **the amendment and modification of the FY 02/03 Budget to include line item Capital**
15 **Equipment for said purposes.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day**
17 **of APRIL, 2003 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;**
18 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3)**
19 **of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
20 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
21 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


