5 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby
6 recognize that the above-named person(s) have relinquished their membership in
7 this Nation, and does hereby order that their name(s) be deleted from the
8 membership roll.

9 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05th Day
10 of MAY 2003 at a meeting at which a quorum was present with a vote of 2,302.15 FOR; -0- AGAINST;
11 115.35 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article II,
12 Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'Odham Nation, adopted
13 by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
14 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
15 18, 1934 (48 Stat. 984).


