**RESOLUTION NO. 03-201**

1 **WHEREAS, by Resolution Nos. 02-608 and 03-042, Sial Thonolig was appointed to serve as an**  
2 **initial commissioner of the Tohono O'odham Boxing Commission for a term which**  
3 **expired on March 28, 2003; and**


4 **WHEREAS, it is in the interests of the Nation to reappoint Sial Thonolig to the Tohono O'odham**  
5 **Boxing Commission as an initial commissioner; and**

6 **WHEREAS, Sial Thonolig agrees to serve as an initial commissioner of the Tohono O'odham**  
7 **Boxing Commission.**

8 **NOW, THEREFORE, BE IT RESOLVED that Sial Thonolig is reappointed to the Tohono**  
9 **O'odham Boxing Commission as an Initial Commissioner. Mr. Thonolig's term shall**  
10 **expire on November 10, 2003.**

11 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup> Day**  
12 **of MAY, 2003 at a meeting at which a quorum was present with a vote of 1,389.55 FOR; 935.6**  
13 **AGAINST; 92.35 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
14 **Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
15 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
16 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
17 **18, 1934 (48 Stat. 984).**






