

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Adopting Amended Tohono O'odham Legislative Council Judicial Appointment Procedure  
and Repealing Judicial Appointment Procedure Adopted by Legislative Order No. 01-040  
and Amended by Legislative Order No. 02-207)**

**LEGISLATIVE ORDER NO. 03-204**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to appoint judges**  
2 **to the Tohono O'odham Judicial Court pursuant to Section 3 of Article VIII of the**  
3 **Constitution of the Tohono O'odham Nation; and**

4 **WHEREAS, the Legislative Council did adopt and later amend a Judicial Appointment Procedure**  
5 **governing the process for appointing Tohono O'odham Judicial Court judges**  
6 **(Legislative Order Nos. 01-040 and 02-207); and**

7 **WHEREAS, the Judiciary Committee now recommends the adoption of the attached Amended**  
8 **Judicial Appointment Procedure, which is hereby incorporated by this reference, to**  
9 **further clarify the appointment process; and**

10 **WHEREAS, the Legislative Council has reviewed the attached "Amended Judicial Appointment**  
11 **Procedure."**

12 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it hereby**  
13 **adopts the Amended Judicial Appointment Procedure and repeals the Judicial**  
14 **Appointment Procedure adopted by Legislative Order No. 01-040 and amended by**  
15 **Legislative Order No. 02-207.**

16 **BE IT FURTHER ORDERED that the Amended Judicial Appointment Procedure shall become**  
17 **effective immediately and shall govern the Legislative Council's process for**  
18 **appointing judges to the Tohono O'odham Judicial Court.**

19 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup> Day of**  
20 **MAY, 2003 at a meeting at which a quorum was present with a vote of 2,293.45 FOR; 124.05**  
21 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
22 **Section 1 (a) of Article VI and Section 3 of Article VIII of the Constitution of the Tohono O'Odham**  
23 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**  
24 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**  
25 **of the Act of June 18, 1934 (48 Stat. 984).**
