**RESOLUTION NO. 03-213**

1 **WHEREAS, Low Income Home Energy Assistance (LIHEAP) funds have been made available to the**  
2 **Tohono O'odham Nation for FY2004 through the State of Arizona, Department of**  
3 **Commerce; and**

4 **WHEREAS, the Tohono O'odham Nation does meet the eligibility requirements to operate a Low**  
5 **Income Home Energy Assistance Program; and**

6 **WHEREAS, the Tohono O'odham Nations' application for FY2004 funding was approved through**  
7 **the State of Arizona, Department of Commerce in the amount of \$53,980.00 for**  
8 **contract period July 01, 2003 through June 30, 2004; and**

9 **WHEREAS, the Tohono O'odham Department of Human Services, Family Assistance Division,**  
10 **Low Income Home Energy Assistance Program has submitted the FY04 Low Income**  
11 **Home Energy Assistance scope of work and budget in the amount of \$53,980.00 for**  
12 **review and approval.**

13 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 14 **1. It hereby approves and authorizes the proposed FY2004 Low Income Home Energy**  
15 **Assistance Program (LIHEAP) budget in the amount of \$53,980.00, and authorizes**  
16 **expenditures in accordance with the attached budget.**
- 17 **2. That the Tohono O'odham Nation's official to wit: The Chairman is hereby**  
18 **authorized to negotiate and execute the contract.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup> Day**  
20 **of MAY, 2003 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;**  
21 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**  
22 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
23 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
24 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
