1	WHEREAS, pursuant to Resolution No. 2000-201, the Legislative Council approved an
2	appropriation for the renovation and construction of Early Childhood/Headstart
3	Centers (the "Centers") and authorized the Chairman of the Nation to negotiate and
4	execute contracts for construction of the Centers; and
5	WHEREAS, the Nation's Department of Education and the Office of Special Projects recommend
6	construction of three new Centers in Pisinemo, Santa Rosa and Vaya Chin under a
7	proposed contract (the "Contract") substantially in the form attached hereto; and
8	WHEREAS, $$ it is in the interests of the Nation for the Centers to be constructed under the terms of
9	the Contract; and
10	WHEREAS, the Contract provides certain remedies to the Nation and the contractor for breach of
11	the Contract; and
12	WHEREAS, the remedies available to the contractor against the Nation constitute a limited waiver
13	of sovereign immunity by the Nation; and
14	WHEREAS, the Health and Human Services Committee recommends approval of the Contract.
15	NOW, THEREFORE, BE IT RESOLVED THAT:
16	1. The Tohono O'odham Legislative Council approves the Contract substantially in
17	the form attached hereto.
18	2. The Legislative Council grants a limited waiver of sovereign immunity for the
19	remedies provided in the Contract which extend to proven sums owed by the
20	Nation to the Contractor.
