9	incumbent upon the Election Board to certify to the Legislative Council these election
10	results, provided, that no election contest statements have been filed within the time
11	allowed; and
12	WHEREAS, Rita Martinez, an eligible voter of the Nation did file a contest statement with the
13	Election Board within the time allowed and on May 7, 2003 did withdraw her contest
14	statement as evidenced in the attached letter.
