

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the allocation of the remainder of the Phoenix Indian School Trust
Fund distribution, \$225,343.40 to the Child Welfare Division Budget)**

RESOLUTION NO. 03-221

1 **WHEREAS, the Tohono O'odham Nation was notified in November, 1999 by the Executive Director**
2 **of the Inter-Tribal Council of Arizona, Mr. John R. Lewis, that the Nation is scheduled**
3 **to receive its first distribution of the Arizona Inter-Tribal Trust Fund distribution in**
4 **the amount of \$400,000.00 in December, 1999 under Public Law 100-969, Arizona Inter-**
5 **Tribal and Navajo Trust Fund; and**

6 **WHEREAS, by Resolution No. 2000-253, the Legislative Council approved an allocation of**
7 **\$174,565.60 to the Department of Human Services Child Welfare Division; and**

8 **WHEREAS, presently there are still unspent funds in the amount of \$225,343.40 from the first**
9 **distribution; and**

10 **WHEREAS, by agreement with the Nation's Executive Office and Department of Human Services,**
11 **the remainder of the Arizona Inter-Tribal Trust Fund will fund the reclassification of**
12 **Child Welfare Specialist positions, one (1) additional Child Welfare Specialist position,**
13 **and two (2) additional Child Welfare Specialist Aide positions, effective July 1, 2003;**
14 **and**

15 **WHEREAS, by agreement with the Nation's Executive Office and Department of Human Services,**
16 **the amount of \$41,399.08 will continue funding the budget of the Department of**
17 **Human Services Child Welfare Division for the period of October 1, 2002 - September**
18 **30, 2003, and the amount of \$183,944.32 will fund the budget of the Department of**
19 **Human Services Child Welfare Division for the period of October 1, 2003 - September**
20 **30, 2004.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves:**

- 22 **1. The remaining amount of \$225,343.40 to be allocated from the \$400,000.00**
23 **proceeds of the Phoenix Indian School Trust Fund distribution for funding the**
24 **budget of the Department of Human Services Child Welfare Division.**
- 25 **2. The attached budget of the Department of Human Services Child Welfare Division**
26 **to utilize the amount of \$41,399.08 from this allocation for the period of October**
27 **01, 2002 - September 30, 2003 inclusive of budget modifications during the year.**
- 28 **3. The Tohono O'odham Nation's officials to wit: the Chairman and Vice-Chairman**
29 **and any designated official are hereby authorized to negotiate, execute and**
30 **expend the grant.**


