

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Supporting the San Xavier District's People Wellness House Grant Application to
the Office of Juvenile and Delinquency Prevention's FY 2003 Tribal Youth Program)

RESOLUTION NO. 03-224

1 **WHEREAS, the People Wellness House (a department of the San Xavier District government)**
2 **promotes individual and family wellness through education, prevention and**
3 **intervention services for the Tohono O'odham San Xavier District community; and**

4 **WHEREAS, this mission includes providing delinquency prevention and intervention programs**
5 **for court-involved youth, which includes cultural and language classes to community**
6 **youth; and**

7 **WHEREAS, the Wa:k Community Plan includes providing social services, reducing delinquency,**
8 **and promoting youth and family wellness as priorities for the District over the next**
9 **five years; and**

10 **WHEREAS, the People Wellness House desires to expand its programs to meet these goals, and**
11 **especially to address the problems of community youth delinquency, violence and**
12 **domestic violence, but lacks the staff and financial resources to do so; and**

13 **WHEREAS, there is a pressing need for additional staff at the People Wellness House to perform**
14 **outreach, increase parental and family involvement in youth programs, work with**
15 **court-involved youth, and develop and lead wellness and prevention workshops for**
16 **community youth and their families; and**

17 **WHEREAS, the Office of Juvenile Justice and Delinquency Prevention's (OJJDP) FY 2003 Tribal**
18 **Youth Program presents an opportunity to obtain funding for this additional staff;**
19 **and**

20 **WHEREAS, the Tribal Youth Program offers a maximum award of \$300,000 over a three year**
21 **project period for tribal communities with 10,000 or fewer residents, and does not**
22 **have a match requirement.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
24 **supports the San Xavier District's People Wellness House's application to the OJJDP**
25 **FY 2003 Tribal Youth Program.**

26 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes**
27 **the San Xavier District officials to execute all necessary documents related to**
28 **obtaining OJJDP grant funds, and with programmatic and financial reporting**
29 **requirements.**


