1	WHEREAS, pursuant to Resolution No. 2000-087 the Tohono O'odham Nation accepted an
2	invitation from the Smithsonian Institution's National Museum of the American
3	Indian to participate in the "Our Peoples" exhibit which would highlight the opening
4	of the National Museum of the American Indian in 2004; and
5	WHEREAS, the Council appointed a four-member committee and two alternates to represent the
6	Tohono O'odham Nation and work with the staff of the National Museum of the
7	American Indian to design and create the Tohono O'odham Nation exhibit as part of
8	the larger "Our Peoples" exhibit; and
9	WHEREAS, Simon Lopez was one of the members appointed to this committee; and
10	WHEREAS, Simon Lopez has expressed to the Cultural Preservation Committee that he no longer
11	wishes to be a member of this committee; and
12	WHEREAS, the Cultural Preservation Committee has discussed this issue and recommends that
13	alternate Stanley Cruz be appointed to this committee to replace Simon Lopez.
14	NOW, THEREFORE, BE IT RESOLVED that the Legislative Council hereby appoints alternate
15	Stanley Cruz to replace Simon Lopez on the four-member committee to represent the
16	Tohono O'odham Nation and work with the staff of the National Museum of the
17	American Indian to design and create the Tohono O'odham Nation exhibit as part of
18	the larger "Our Peoples" exhibit.
