

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Apportionment of District Vote on the Tohono O'odham Legislative Council)**

RESOLUTION NO. 03-235

1 WHEREAS, the Tohono O'odham Nation did on Saturday, May 24, 2003 conduct a general
2 election for the offices of Representatives and Alternates to the Tohono O'odham
3 Legislative Council; and

4 WHEREAS, the Election Board did issue and post its Certificates of Election Results in
5 accordance with Section 6(K) of Article VII of the Uniform Election Ordinance; and

6 WHEREAS, pursuant to Section 1 (B) of Article VII of the Uniform Election Ordinance, the
7 Certificate of District Vote was also posted apportioning the number of votes each
8 district is entitled to cast on the Tohono O'odham Legislative Council in accordance
9 with Section 2, of Article V of the Constitution of the Tohono O'odham Nation, and is
10 herein attached; and

11 WHEREAS, the number of votes totals 2,629.7.

12 NOW, THEREFORE, BE IT RESOLVED THAT the Tohono O'odham Legislative Council does hereby
13 accept the apportionment of votes each district is entitled to cast on the Tohono
14 O'odham Legislative Council as herein attached.

15 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02nd, Day
16 of JUNE, 2003 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;
17 -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 2 of
18 Article V and Section 1(g) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted
19 by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
20 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
21 18, 1934 (48 Stat. 984).




