

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Issuance of Certificates of Election from the May 24, 2003 General Election, for the Offices of Chairman and Vice Chairman of the Tohono O'odham Nation and Representatives to the Tohono O'odham Legislative Council and Seating such Elected Officials)

RESOLUTION NO. 03-236

1 **WHEREAS, the Tohono O'odham Nation did on Saturday, May 24, 2003 conduct a general**
2 **election for the offices of Chairman and Vice-Chairman of the Tohono O'odham**
3 **Nation, as well as Representatives to the Tohono O'odham Legislative Council; and**

4 **WHEREAS, on May 25, 2003 the Election Board did issue and post its attached Certification of**
5 **Election Results in accordance with Section 6(K) of Article VII of the Uniform Election**
6 **Ordinance and is incorporated herein by this reference; and**

7 **WHEREAS, Section 6(N) of Article VII of the Uniform Election Ordinance, requires that the**
8 **Legislative Council issue Certificates of Election to the candidates who receive the**
9 **highest number of votes for Chairman and Vice Chairman of the Nation and for each**
10 **Council seat within twenty days after the Election Board has posted its Certificates**
11 **of Election results, provided however, that no election contest statement has been**
12 **filed within the time allowed and provided further that they hold no other elective**
13 **office of the Nation and in the case of Chairman and Vice Chairman of the Nation**
14 **such persons hold no other elective offices in the Nation and are not employees of**
15 **the Nation.**

16 **NOW, THEREFORE BE IT RESOLVED THAT the Chairman and Secretary of the Tohono O'odham**
17 **Legislative Council are hereby authorized and directed on behalf of the Council to**
18 **execute and deliver a Certificate of Election seating the following persons elected**
19 **either at large as Chairman and Vice Chairman of the Tohono O'odham Nation, or**
20 **from their respective Districts as Representatives and Alternates to the Tohono**
21 **O'odham Legislative Council, who shall hold their offices for a term of four (4) years**
22 **or until their successors have been elected, certified and seated, namely:**


