(Certifying Reappointments by Retention of Dennis Jose, Isidro Lopez, Felicia Nunez,  
Sandra Ortega to the Housing Committee)**

**LEGISLATIVE ORDER NO. 03-246**

1 **WHEREAS, on June 2, 2003, the Tohono O'odham Legislative Council proceeded with**  
2 **appointments of Legislative Committees; and**

3 **WHEREAS, each duly elected Member of the Tohono O'odham Legislative Council submitted a**  
4 **"Declaration of Candidacy" form which specified their choices for Membership to**  
5 **the Legislative Committees; and**


6 **WHEREAS, the Legislative Rules, Article XII, Section 3.B provides for "Retention of Current**  
7 **Committee Membership" for any Member who wishes to remain on an existing**  
8 **committee; and**

9 **WHEREAS, Councilmembers Dennis Jose, Isidro Lopez, Felicia Nunez, Sandra Ortega submitted**  
10 **their requests to be retained on the Housing Committee.**

11 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council does hereby**  
12 **reappoint by retention Councilmembers Dennis Jose, Isidro Lopez, Felicia Nunez,**  
13 **and Sandra Ortega to the Housing Committee.**

14 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 02<sup>ND</sup>, Day of**  
15 **JUNE 2003 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**  
16 **-0- NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by Section 1 (b)**  
17 **of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
18 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
19 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
