(Certifying Seniority Preference Appointments of Patricia Cruz, Evelyn Juan, Gloria Ramirez,
Isidro Lopez to the Domestic Affairs Committee)**

LEGISLATIVE ORDER NO. 03-257

1 **WHEREAS, on June 2, 2003, the Tohono O'odham Legislative Council proceeded with**
2 **appointments of Legislative Committees; and**

3 **WHEREAS, each duly elected Member of the Tohono O'odham Legislative Council submitted**
4 **a "Declaration of Candidacy" form which specified their choices for Membership**
5 **to the Legislative Committees; and**


6 **WHEREAS, the Legislative Rules, Article XII, Section 3.C provides for "Seniority Preference**
7 **Appointment" for any Member who wishes to request for a Seniority Preference**
8 **Appointment to a committee of their choice; and**

9 **WHEREAS, Councilmembers Patricia Cruz, Evelyn Juan, Gloria Ramirez, Isidro Lopez**
10 **submitted their requests for seniority preference appointments to the Domestic**
11 **Affairs Committee.**

12 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council does hereby**
13 **appoint by seniority preference Councilwomen Patricia Cruz, Evelyn Juan, Gloria**
14 **Ramirez, and Councilman Isidro Lopez to the Legislative Council Domestic Affairs**
15 **Committee.**

16 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 02ND Day of**
17 **JUNE 2003 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**
18 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (b)**
19 **of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
20 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
21 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
