5	Program has been provided in part through supplemental funding sources; and
6	WHEREAS, the Division of Community Health Services - Tuberculosis Control Services desires to
7	continue the services it provides to TB susceptible patients; and
8	WHEREAS, the Tohono O'odham Tuberculosis Control Services Program has received funding
9	from the State of Arizona, Department of Health Services for its program; and
10	WHEREAS, a budget in the amount of \$21,356.00 is submitted for review and approval by the
11	Department of Human Services, Division of Community Health to utilize funds to
12	continue the services it provides.
13	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:
14	1. It hereby approves the proposal for funding of the Tohono O'odham
15	Tuberculosis Control Services Program from the State of Arizona Department of Arizona Department of Theorem Depa
16	Health Services and approves expenditures in accordance with the attached
17	budget in the amount of \$21,356.00.
18	2. That the duration of this contract shall be from July 01,2002 and remain in effec
19	as long as the Arizona Department of Health Services agrees to fund the Tohono
20	O'odham Tuberculosis Control Services Program.
21	3. The Tohono O'odham Nation Officials, to wit: the Chairman and Vice Chairman
