

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Rescinding Resolution No. 03-281 and Resolution No. 03-282)**

RESOLUTION NO. 03-287

1 **WHEREAS, on June 03, 2003, following a presentation by the Enrollment Committee, the Tohono**
2 **O'odham Legislative Council did enact Resolution No. 03-281, *Correcting Enrollment***
3 ***Resolution #98-206* and 03-282, *Correcting Enrollment Resolution #95-319* to**
4 **correct mistakes made in the name of, and/or in the numbers assigned and/or blood**
5 **degree to certain applicants; and**

6 **WHEREAS, the Legislative Council in discussion with the Enrollment Committee and the**
7 **Assistant Attorney General determined a need for an alternative corrective action**
8 **which will require rescinding Resolution Nos. 03-281 and 03-282.**

9 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
10 **rescinds Resolution Nos. 03-281 and 03-282.**

11 **BE IT FURTHER RESOLVED that the matter will be readdressed during the July**
12 **2003 General Session following a review and recommendation by the Office of**
13 **Attorney General on the appropriate course of action for addressing proposed**
14 **corrections by the Enrollment Committee.**

15 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 3RD. Day**
16 **of JUNE 2003 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**
17 **-0- NOT VOTING; and [0] ABSENT, pursuant to the powers vested in the Council by Section I of**
18 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
19 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
20 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


