

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Judges Pro Tempore of the Tohono O'odham Courts)**

RESOLUTION NO. 03-291

1 **WHEREAS, the Legislative Council is empowered by Article VIII, Section 4 of the Constitution of**
2 **the Tohono O'odham Nation to appoint judges of the Tohono O'odham Courts; and**

3 **WHEREAS, the Legislative Council did by Ordinance No. 01-89, Chapter II, authorize the**
4 **appointment of judges pro tempore to the Tohono O'odham Courts upon the**
5 **recommendation of the Chief Judge; and**

6 **WHEREAS, the Chief Judge has submitted the names of attorneys qualified pursuant to 2-103 of**
7 **Ordinance No. 01-89 and recommended their appointment as judges pro tempore of**
8 **the Tohono O'odham Judicial Courts; and**

9 **WHEREAS, Ordinance 01-89, Chapter II allows the appointment of judges pro tempore for terms**
10 **no greater than six years; and**

11 **WHEREAS, the Chief Judge has submitted the names of two attorneys qualified to fill the current**
12 **expired terms of judge pro tempore; and**

13 **WHEREAS, the Judiciary Committee has met with the Chief Judge and discussed the**
14 **qualifications of the individuals who are being recommended for appointment as**
15 **judges pro tempore; and**

16 **WHEREAS, the Judiciary Committee has determined that the persons recommended are of good**
17 **moral character, residents of the State of Arizona for not less than five years, and are**
18 **admitted to the practice of law for not less than three years; and**

19 **WHEREAS, the Judiciary Committee does concur with the recommendations of the Chief Judge**
20 **and recommends to the full Legislative Council two appointments of judges pro**
21 **tempore for the Judicial Court of this Nation.**

22 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does accept**
23 **the recommendation of the Chief Judge and, in accordance with Judicial Branch**
24 **Rules and Procedures formally adopted pursuant to Ordinance 01-89, Chapter II,**
25 **hereby appoints the following named persons with the respective terms as judges pro**
26 **tempore of the Tohono O'odham Judicial Court:**

27 **Julia Corty, beginning May 01, 2003 and ending April 30, 2005.**

28 **Paul Julien, beginning May 01, 2003 and ending April 30, 2005.**

1 BE IT FINALLY RESOLVED that the appointments of the foregoing named persons shall become
2 effective upon the signature of the Chairwoman of the Tohono O'odham Nation.

3 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH Day
4 of JUNE, 2003 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;
5 -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Section 4 of
6 Article VIII of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
7 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
8 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
