


**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting Tentative Tohono O'odham Legislative Council Committee Meeting Schedule
Thru July 2003)**

LEGISLATIVE ORDER NO. 03-294

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "establish rules**
2 **and procedures to regulate all meetings of the Tohono O'odham Council" pursuant**
3 **to Section 1 (a) of Article VI of the Constitution of the Tohono O'odham Nation; and**
4 **WHEREAS, the Rules Committee has been charged with developing the Legislative Council**
5 **Committee Meeting Schedule for the 2003-2004 Legislative Session; and**
6 **WHEREAS, the Rules Committee, in accordance with the newly-established committee**
7 **memberships, has developed a tentative "Tohono O'odham Legislative Council**
8 **Committee Meeting Schedule (Thru July 2003)" and now recommends its adoption.**
9 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it hereby**
10 **adopts the attached tentative "Tohono O'odham Legislative Council Committee**
11 **Meeting Schedule (Thru July 2003)" presented by the Rules Committee.**

12 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 06TH Day of**
13 **JUNE, 2003 at a meeting at which a quorum was present with a vote of 2,286.0 FOR; 175.4 AGAINST;**
14 **168.3 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (a)**
15 **of Article VI of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January**
16 **18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on**
17 **March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
