19 is eligible for enrollment as a member of the Tohono O'odham Nation under
20 Section 1(a) or (b) of Article II of the Constitution of the Tohono O'odham Nation,
21 and that their application is approved, as herein above indicated.

22 **BE IT FURTHER RESOLVED** that the Chairman and other appropriate officers of the Tohono
23 O'odham Nation reduce this final determination in writing regarding each of the
24 foregoing applications for enrollment in accordance with Section 1(a) of Article
25 XIII of the Enrollment Ordinance; give notice of this Council's determination in
26 accordance with Section 2 of Article XIII of the Enrollment Ordinance; and place
27 the names of each applicant upon the membership roll of the Tohono O'odham
28 Nation in accordance with Sections 2 and 3 of Article X of the Enrollment
29 Ordinance.

30 The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 07TH. Day
31 of JULY 2003 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;
32 -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 of
33 Article II and Section 1(h) of Article VI of the Constitution of the Tohono O'Odham Nation,
34 adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy
35 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
36 Act of June 18, 1934 (48 Stat. 984).
