

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Modifying Enrollment Resolution No. 02-280)**

RESOLUTION NO. 03-304

1 **WHEREAS, the Legislative Council is vested with the power to “enact laws and ordinances for**
2 **governing the enrollment and adoption of members and the relinquishment and loss**
3 **of membership” (Constitution of the Tohono O’odham Nation, Article VI, Section 1 (h);**
4 **and**

5 **WHEREAS, Article VIII, Section 1 of the Enrollment Ordinance, Ordinance No. 5-81 (as amended)**
6 **provides that the Legislative Council shall determine Applicant’s eligibility for**
7 **enrollment or adoption; and**

8 **WHEREAS, on March 1, 1999 the Legislative Council, pursuant to Resolution No. 99-080, approved**
9 **Kimberlee E. Dora, 1601-GB-97 for membership in the Tohono O’odham Nation; and**

10 **WHEREAS, on July 8, 2002 the Legislative Council, pursuant to Resolution No. 02-280 approved**
11 **Kimberly E. Dora, 2084-GB-02 for membership in the Tohono O’odham Nation; and**

12 **WHEREAS, the Enrollment Committee has determined, based on the individual’s date of birth,**
13 **and family tree, that Kimberlee E. Dora listed with Roll No. 1601-GB-97 and Kimberly**
14 **E. Dora listed with Roll No. 2084-GB-02 is the same individual; and**

15 **WHEREAS, the Enrollment Manual at page 5, (*Filing of Applications*) provides that once a**
16 **number has been assigned to an application it shall not be changed; and**

17 **WHEREAS, Article X, Section 3 of the Enrollment Ordinance provides that the Tohono O’odham**
18 **Legislative Council shall cause the membership roll to be kept current.**

19 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 20 **1. The Tohono O’odham Legislative Council approves a modification of Resolution**
21 **No. 02-280 as follows:**

22 **The Roll No. listed for Kimberly E. Dora is changed to 1601-GB-97 to reflect**
23 **the number originally assigned to the application of Kimberlee E. Dora in**
24 **1999 which was approved by this Council pursuant to Resolution No. 99-080.**

- 25 **2. The Enrollment Committee shall make the necessary changes in the records of**
26 **the Enrollment Office to incorporate the stated modification.**

28 **The foregoing Resolution was passed by the Tohono O’odham Legislative Council on the 07TH, Day**
29 **of JULY, 2003 at a meeting at which a quorum was present with a vote of 1,381.05 FOR; 1,248.65**
30 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
31 **Section 1(h) of Article VI of the Constitution of the Tohono O’Odham Nation, adopted by the Tohono**
32 **O’Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
33 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
34 **Stat. 984).**




