

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Modifying Enrollment Resolution No. 2000-554)**

RESOLUTION NO. 03-305

1 **WHEREAS, the Legislative Council is vested with the power to “enact laws and ordinances for**
2 **governing the enrollment and adoption of members and the relinquishment and loss**
3 **of membership” (Constitution of the Tohono O’odham Nation, Article VI, Section 1 (h);**
4 **and**

5 **WHEREAS, Article VIII, Section 1 of the Enrollment Ordinance, Ordinance No. 5-81 (as amended)**
6 **provides that the Legislative Council shall determine Applicant’s eligibility for**
7 **enrollment or adoption; and**

8 **WHEREAS, on June 1, 1998 the Legislative Council, pursuant to Resolution No. 98-206, approved**
9 **Anehim L. Garcia-Manuel, Roll No. 1935-GV-98 for membership in the Tohono**
10 **O’odham Nation; and**

11 **WHEREAS, on December 4, 2000 the Legislative Council, pursuant to Resolution No. 2000-554**
12 **approved Anehim L. Garcia-Manuel, Roll No. 2160-GV-00 for membership in the**
13 **Tohono O’odham Nation; and**

14 **WHEREAS, the Enrollment Committee has determined, based on the individual’s date of birth,**
15 **and family tree, that Anehim L. Garcia-Manuel listed with Roll No. 1935-GV-98 and**
16 **2160-GV-00 is the same individual; and**

17 **WHEREAS, the Enrollment Manual at page 5, (*Filing of Applications*) provides that once a**
18 **number has been assigned to an application it shall not be changed; and**

19 **WHEREAS, Article X, Section 3 of the Enrollment Ordinance provides that the Tohono O’odham**
20 **Legislative Council shall cause the membership roll to be kept current.**

21 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 22 **1. The Tohono O’odham Legislative Council approves a modification of Resolution**
23 **No. 2000-554 as follows:**

24 **The Roll No. listed for Anehim L. Garcia-Manuel is changed to 1935-GV-98**
25 **to reflect the number originally assigned to the application of Anehim L.**
26 **Garcia-Manuel in 1998 which was approved by this Council pursuant to**
27 **Resolution No. 98-206.**

- 28 **2. The Enrollment Committee shall make the necessary changes in the records of**
29 **the Enrollment Office to incorporate the stated modification.**

7 **Stat. 984).**




