

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2004 Distribution of Gaming Revenues by 50/50 Distribution)**

**RESOLUTION NO. 03-311**

1 **WHEREAS, during the July 08, 2003 General Session, the Budget and Finance Committee did**  
2 **present three options on the distribution of gaming revenues for consideration by the**  
3 **Legislative Council: 1) equal distribution; 2) population distribution; and 3) 50/50**  
4 **distribution (½ equal and ½ population); and**

5 **WHEREAS, on June 11, 2003 the Budget & Finance Committee made a presentation to the District**  
6 **Chairpersons regarding the current figures for each district under the gaming**  
7 **distribution; and**

8 **WHEREAS, the Legislative Council does hereby approve distribution of gaming revenues by 50/50**  
9 **Distribution.**

10 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
11 **approves and authorizes the FY 2004 distribution of gaming revenues by 50/50**  
12 **Distribution.**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup> Day**  
14 **of JULY, 2003 at a meeting at which a quorum was present with a vote of 2,008.6 FOR; 621.1**  
15 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
16 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
17 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
18 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
19 **18, 1934 (48 Stat. 984).**




