

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment No. 1 to the Attorney Contract with Rusing & Lopez, P.L.L.C.)**

RESOLUTION NO. 03-315

1 **WHEREAS, by Resolution 02-521, the Tohono O'odham Legislative Council approved an Attorney**
2 **Contract with Rusing & Lopez, P.L.L.C. to provide legal representation to the Nation**
3 **in matters pertaining to the Coleman Road trespass; and**

4 **WHEREAS, the Attorney General recommends increasing the contract amount by \$30,000 for the**
5 **period ending September 30, 2003, to assure uninterrupted legal representation; and**

6 **WHEREAS, sufficient funds are available in the budget of the Office of Attorney General for the**
7 **recommended contract amendment; and**

8 **WHEREAS, the Domestic Affairs Committee recommends approval of Amendment No. 1 to the**
9 **Attorney Contract.**

10 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 11 **1. The Tohono O'odham Legislative Council hereby approves Amendment No. 1 to**
12 **the Attorney Contract with Rusing & Lopez, P.L.L.C. in the form attached hereto,**
13 **which increases the Contract amount by \$30,000 payable from the fiscal year 2003**
14 **operating budget of the Office of Attorney General.**
- 15 **2. The Chairwoman of the Nation is authorized and directed to execute Amendment**
16 **No. 1 to such Contract.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH. Day**
18 **of JULY, 2003 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**
19 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 2 (a) of**
20 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
21 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
22 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


