

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting Legislative Calendar for July 7, 2003 to the October 2003 General Session)**

LEGISLATIVE ORDER NO. 03-321

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "establish rules**
2 **and procedures to regulate all meetings of the Tohono O'odham Council" pursuant**
3 **to Section 1(a) of Article VI of the Constitution of the Tohono O'odham Nation; and**

4 **WHEREAS, the Legislative Council has adopted Legislative Rules requiring that "Prior to an**
5 **official adjournment, the Legislative Council shall adopt a Legislative Calendar which**
6 **shall commence on the first working day of June on which the Legislative Council will**
7 **be called into Legislative Session." (Legislative Rules, Article I, Section 1.A.1., as**
8 **adopted by Resolution No. 172-87); and**

9 **WHEREAS, the Rules Committee has been charged with developing the Legislative Council**
10 **Calendar for the 2003-2004 Legislative Session; and**

11 **WHEREAS, the Rules Committee did present a one month Legislative Calendar during the June**
12 **2003 General Session adopted as Legislative Order No. 03-294; and**

13 **WHEREAS, the Rules Committee, in accordance with the Legislative Rules, has developed a**
14 **"Tohono O'odham Legislative Council Calendar" for July 7, 2003 through the October**
15 **2003 General Session and now recommends its adoption.**

16 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it hereby**
17 **adopts the three (3) month "Tohono O'odham Legislative Council Calendar for the**
18 **period July 7, 2003 through the October 2003 General Session" as presented by the**
19 **Rules Committee.**

20 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 11TH Day of**
21 **JULY, 2003 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST; -0-**
22 **NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (a) of**
23 **Article VI of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18,**
24 **1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March**
25 **6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


