

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 03 Schuk Toak District Budget Modification #1)**

RESOLUTION NO. 03-330

1 WHEREAS, the Schuk Toak District Administration presented to the Tohono O'odham Legislative  
2 Council the District FY 03 Budget modification #1 adding new line items and  
3 additional monies to cover over expenditures and anticipated expenditures to the  
4 end of the fiscal year; and

5 WHEREAS, the Tohono O'odham Legislative Council did previously approve the Schuk Toak  
6 District Fiscal Year 2003 Budget in the amount of \$414,699.00; and

7 WHEREAS, the Schuk Toak District Council at its regular meeting held on July 12, 2003 did review  
8 and approve the District Administration budget modification adding additional  
9 monies in the amount of \$90,000.00 utilizing Schuk Toak District FY 02 Budget savings  
10 per the attached resolution; and

11 WHEREAS, there are sufficient amounts from the Schuk Toak District FY 02 savings in District  
12 accounts held by Wachovia Securities to cover the approved budget modification.

13 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves  
14 the Schuk Toak District FY 03 Budget Modification #1 in the amount of \$90,000.00 as  
15 presented, utilizing District FY 02 savings to be expended in accordance with the  
16 attached budget.

17 BE IT FINALLY RESOLVED that the Schuk Toak District Fiscal Year 2003 budget is hereby modified  
18 from \$414,699.00 to the approved level of \$504,699.00 .

19 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>ST</sup>, Day  
20 of JULY, 2003 at a meeting at which a quorum was present with a vote of 2,463.4 FOR; -0- AGAINST;  
21 166.3 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1  
22 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
23 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
24 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
25 Stat. 984).






