

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Continuing Resolution for the Sif-Oidak District FY 2003 Budget)**

**RESOLUTION NO. 03-331**

1 **WHEREAS, the Sif-Oidak District FY 2004 Budget is pending further review by the Communities;**  
2 **and**

3 **WHEREAS, in order for the District to continue its operations pending the approval and adoption**  
4 **of a budget, it is recommended that a continuing resolution be authorized for an**  
5 **additional three months.**

6 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
7 **approve the Continuing Resolution for the Sif-Oidak District FY 2003 Budget for an**  
8 **additional three month period to October 31, 2003.**


9 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>ST</sup>, Day**  
10 **of JULY, 2003 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**  
11 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**  
12 **of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
13 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
14 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
