

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Budget Modification #1 Authorizing Transfer of \$168,718.07 from Executive-Special Counsel Account No. 01-3037 to Environmental Trust Fund Account No. 19-1096-871 for the purpose of Emergency Disaster Relief Caused by Storm Damage)**

**RESOLUTION NO. 03-336**

1 **WHEREAS, the Executive Office was notified by various Districts of damage that occurred to**  
2 **homes throughout their Districts between July 15 and July 22, 2003 due to severe**  
3 **storms; and**

4 **WHEREAS, the Districts have requested financial assistance from the Tohono O'odham Nation**  
5 **("Nation") for addressing the damages caused by the storms; and**

6 **WHEREAS, the Tohono O'odham Legislative Council by Resolution No. 2000-194 authorized the**  
7 **establishment of an Environmental Trust Fund to be used by the Nation for prompt**  
8 **response to a broad range of natural disasters; and**

9 **WHEREAS, the Environmental Trust Fund currently has an available balance of \$15,557.45 that**  
10 **is not sufficient to cover the current damage assessment; and**

11 **WHEREAS, Executive has identified unused funds in Executive-Special Counsel Account No. 01-**  
12 **3037 in the amount of \$168,718.07; and**

13 **WHEREAS, in order to promptly respond to the damage caused by the storms and assist the**  
14 **Districts and O'odham families, the Executive requests a Budget Modification No. 1**  
15 **authorizing transfer of \$168,718.07 from Executive-Special Counsel Account No. 01-**  
16 **3037 to Environmental Trust Fund Account No. 19-1096-871.**

17 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby**  
18 **approve the transfer of \$168,718.07 from Executive-Special Counsel Account No. 01-**  
19 **3037 to Environmental Trust Fund Account No. 19-1096-871 to immediately assist the**  
20 **districts and families in addressing the damages caused by the storms.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25<sup>th</sup> Day**  
22 **of JULY, 2003 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**  
23 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1 (c)(2)**  
24 **and 1(d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
25 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
27 **18, 1934 (48 Stat. 984).**


