

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the San Xavier Cooperative Association Equipment Insurance Budget for
Fiscal Year 2004)

RESOLUTION NO. 03-348

1 **WHEREAS, by Resolution No. 98-187, the Tohono O'odham Legislative Council authorized the**
2 **San Xavier Cooperative Association to perform the necessary maintenance on the**
3 **completed bank stabilization of the Santa Cruz River; and**

4 **WHEREAS, by Resolution No. 98-187, the Tohono O'odham Nation authorized the purchase of**
5 **equipment and materials necessary for the continued maintenance of the bank**
6 **stabilization project and within this same resolution the Nation assumed financial**
7 **responsibility for the yearly insurance costs of such equipment; and**

8 **WHEREAS, pursuant to Section 309(a) of the Southern Arizona Water Rights Settlement Act of**
9 **1982 ("SAWRSA"), the Tohono O'odham Nation ("Nation") received \$15,000,000.00 to**
10 **be held in trust by the Nation ("SAWRSA Trust Fund"); and**

11 **WHEREAS, the Nation is authorized to expend accrued interest and dividends from the SAWRSA**
12 **Trust Fund for the "subjugation of land, development of water resources, and the**
13 **construction, operation, maintenance and the replacement of related facilities on**
14 **the Papago Reservation (now known as the Tohono O'odham Reservation) which are**
15 **not the obligation of the United States under ("SAWRSA") or any other Act of**
16 **Congress"; and**

17 **WHEREAS, the assumed financial responsibilities for the yearly insurance costs by the Tohono**
18 **O'odham Nation qualify for funding under the SAWRSA Trust Fund; and**

19 **WHEREAS, the San Xavier Cooperative Association has prepared the attached budget for fiscal**
20 **year 2004 in the amount of \$5,588.00 to cover the yearly insurance of the identified**
21 **equipment as listed; and**

22 **WHEREAS, the San Xavier Cooperative Association budget has been reviewed by the appropriate**
23 **Legislative Committees, the Budget and Finance and Water Resources, and**
24 **approved.**

25 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
26 **approves the San Xavier Cooperative Association Equipment Insurance Budget in**
27 **the amount of \$5,588.00 for fiscal year 2004, in the form attached hereto.**

6 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
7 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
8 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
9 **18, 1934 (48 Stat. 984).**
