

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment No. 1 to Emergency Dispatch Services Agreement With
Drexel Heights Fire District)**

RESOLUTION NO. 03-349

1 **WHEREAS, the Tohono O'odham Nation ("Nation") entered into an Emergency Dispatch Services**
2 **Agreement with Drexel Heights Fire District ("Drexel Heights") on or about August 16,**
3 **2002, approved by Tohono O'odham Legislative Council Resolution No. 02-298; and**

4 **WHEREAS, under the Emergency Dispatch Services Agreement, Drexel Heights provides**
5 **emergency dispatch services to the Nation's Fire Department for Station 231 in the**
6 **San Xavier District for a fee of \$16 per dispatched call; and**

7 **WHEREAS, the Emergency Dispatch Services Agreement became effective on August 16, 2002 and**
8 **terminates by its own terms at the end of one year, on August 15, 2003; and**

9 **WHEREAS, the parties have negotiated Amendment No. 1 to extend the term of the Emergency**
10 **Dispatch Services Agreement in its present form until the end of the Tohono O'odham**
11 **Nation fiscal year, September 30, 2003, at which time the parties anticipate making**
12 **further changes to the Agreement; and**

13 **WHEREAS, this Amendment No. 1 to the Emergency Dispatch Services Agreement has been**
14 **reviewed by the Domestic Affairs Committee and the Budget and Finance Committee**
15 **and is recommended for approval by the Legislative Council.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council**
17 **hereby approves Amendment No. 1 to the Emergency Dispatch Services Agreement**
18 **with Drexel Heights substantially in the form attached hereto and authorizes the**
19 **Chairwoman of the Nation to execute it.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH Day**
21 **of AUGUST, 2003 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
23 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
24 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
26 **Stat. 984).**


