

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Rescinding Legislative Order No. 03-321, "Adopting Legislative Calendar for  
July 7, 2003 to the October 2003 General Session)**

**LEGISLATIVE ORDER NO. 03-352**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "establish rules**  
2 **and procedures to regulate all meetings of the Tohono O'odham Council" pursuant**  
3 **to Section 1(a) of Article VI of the Constitution of the Tohono O'odham Nation; and**

4 **WHEREAS, the Rules Committee had previously developed a tentative Legislative Council**  
5 **Committee Meeting Schedule for the 2003 - 2004 Legislative Session through July**  
6 **2003; and**

7 **WHEREAS, during the July Legislative Council General Session, Legislative Order No. 03-321 was**  
8 **passed which was meant to adopt the tentative Legislative Council Committee**  
9 **Meeting Schedule for the 2003 - 2004 Legislative Session through October 2003; and**

10 **WHEREAS, the title of Legislative Order No. 03-321, "Adopting Legislative Calendar for July 7, 2003**  
11 **to the October 2003 General Session" is incorrect.**

12 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby**  
13 **rescinds Legislative Order No. 03-321, "Adopting Legislative Calendar for July 7, 2003**  
14 **to the October 2003 General Session."**

15 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup> Day of**  
16 **AUGUST, 2003 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**  
17 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1 (a) of**  
18 **Article VI of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18,**  
19 **1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March**  
20 **6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
