

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Adopting Tentative Tohono O'odham Legislative Council Committee Meeting Schedule  
thru October 2003 General Session)**

**LEGISLATIVE ORDER NO. 03-353**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "establish rules**  
2 **and procedures to regulate all meetings of the Tohono O'odham Council" pursuant to**  
3 **Section 1(a) of Article VI of the Constitution of the Tohono O'odham Nation; and**

4 **WHEREAS, the Rules Committee has been charged with developing the Legislative Council**  
5 **Committee Meeting Schedule for the 2003 - 2004 Legislative Session; and**

6 **WHEREAS, the Rules Committee, in accordance with the newly-established committee**  
7 **memberships, has developed a "Tentative Tohono O'odham Legislative Council**  
8 **Committee Meeting Schedule (thru July 2003); and**

9 **WHEREAS, the Rules Committee did present a one month Legislative Council Committee Meeting**  
10 **schedule during the June 2003 General Session adopted as Legislative Order No. 03-294**  
11 **which has since expired; and**

12 **WHEREAS, the Rules Committee, in accordance with the Legislative Rules, has developed a second**  
13 **tentative "Tohono O'odham Legislative Council Committee Meeting Schedule" for July**  
14 **07, 2003 - October 2003 General Session and now recommends its adoption.**

15 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it hereby**  
16 **adopts the attached three (3) month tentative "Tohono O'odham Legislative Council**  
17 **Committee Meeting Schedule for the period of July 07, 2003 through the October 2003**  
18 **General Session" as presented by the Rules Committee.**

19 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup> Day of**  
20 **AUGUST, 2003 at a meeting at which a quorum was present with a vote of 2,546.55 FOR; -0-**  
21 **AGAINST; 83.15 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
22 **Section 1 (a) of Article VI of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation**  
23 **on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
24 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
