

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Setting August 15, 2003 Special Session to Consider Rules Committee Report and  
Recommendations; Legislative Order No. 02-553)**

**LEGISLATIVE ORDER NO. 03-354**

1 **WHEREAS, according to the Legislative Rules, Article I, Section 1.D.1., "The Legislative Council**  
2 **may, by majority vote, call for a Special Session to be held for the purposes of**  
3 **completing unfinished agenda, addressing issues requiring an Executive Session,**  
4 **and/or reviewing special reports from Committees, Programs, or other sources."; and**

5 **WHEREAS, the Legislative Council Rules Committee has requested that a special session be set for**  
6 **August 15, 2003 to consider the committee report and recommendations pursuant to**  
7 **Legislative Order No. 02-553.**


8 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby**  
9 **sets a Special Session for August 15, 2003 to consider the Rules Committee report and**  
10 **recommendations pursuant to Legislative Order No. 02-553.**

11 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup> Day of**  
12 **AUGUST, 2003 at a meeting at which a quorum was present with a vote of 1,234.75 FOR; 1,224.1**  
13 **AGAINST; 170.85 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
14 **Section 1 (a) of Article VI of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation**  
15 **on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
16 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
