

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointment of Evan Thomas as TERO Commissioner)

RESOLUTION NO. 03-360

1 **WHEREAS, the Tohono O'odham Legislative Council pursuant to Section 6 (B)(1) of the TERO**
2 **Ordinance No. 01-85 appoint Commissioners for a three year term or until their**
3 **successor are appointed and qualified; and**
4 **WHEREAS, the Domestic Affairs Committee is the oversight committee for "all TERO matters"**
5 **pursuant to Resolution No. 98-448 authorized by this Council; and**
6 **WHEREAS, the Domestic Affairs Committee conducted a Commissionership search to address the**
7 **expired terms by publicly announcing vacancies to all Districts and requested that**
8 **nominations be submitted for their consideration; and**
9 **WHEREAS, the prior Domestic Affairs Committee did receive nominations to fill vacancies; and**
10 **WHEREAS, the prior Domestic Affairs Committee recommends to the Tohono O'odham Legislative**
11 **Council that Evan Thomas be appointed as a member to the TERO Commission to**
12 **replace the expired term of Neddie Blaine; and**
13 **WHEREAS, the current Domestic Affairs Committee agrees to support and move this nomination**
14 **forward before the Tohono O'odham Legislative Council.**
15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby appoints**
16 **Evan Thomas as TERO Commissioner pursuant to Section 6 (B)(1) & (C) of the TERO**
17 **Ordinance No. 01-85, commencing upon the effective date of this resolution and**
18 **ending on the last day of June 2005.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH. Day**
20 **of AUGUST, 2003 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**
21 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
22 **Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
23 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
25 **18, 1934 (48 Stat. 984).**




