1	WHEREAS,	pursuant to Initiative No. IN-01-97, the Tohono O'odham Legislative Council set aside						
2		\$30 million for the construction and operation of five Recreation Centers; and						
3	WHEREAS,	a Construction Contract (8/7/03 Draft) has been prepared for the construction of						
4		Recreation Centers in the Gu Vo, Hickiwan and Pisinemo Districts, a copy of which is						
5		attached hereto; and						
6	WHEREAS,	the Construction Contract provides certain remedies to the Nation and the						
7		Contractor for breach of the Contract and other claims; and						
8	WHEREAS,	the remedies available to the Contractor are only enforceable upon approval by the						
9		Legislative Council of a limited waiver of the sovereign immunity of the Nation; and						
10	WHEREAS,	the Commerce Committee recommends approval by the Legislative Council of a						
11		limited waiver of sovereign immunity.						
12	NOW, THEREFORE, BE IT RESOLVED THAT:							
13		1. The Tohono O'odham Legislative Council hereby grants a limited waiver of						
14		sovereign immunity for the remedies provided in the Construction Contract						
15		which extend to proven sums owed by the Nation to the Contractor.						
16		2. The limited waiver of sovereign immunity shall be effective upon the date the						
17		Nation and the Contractor execute the Construction Contract in substantially the						
18		form attached hereto.
