

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Adopting Legislative Council Rules Committee Recommendation for Quarterly Reports by  
the Administration regarding Outstanding Travel Per Diem for the Legislative Branch)**

**LEGISLATIVE ORDER NO. 03-370**

1 **WHEREAS, Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation empowers**  
2 **the Legislative Council "[T]o establish rules and procedures to regulate all meetings**  
3 **of the Tohono O'odham Council, standing committees, boards, and special**  
4 **committees"; and**

5 **WHEREAS, the Legislative Council has adopted Legislative Order No. 02-482 Legislative Branch**  
6 **Travel Policy and Rescinding Prior Branch Travel Policies to increase fiscal**  
7 **responsibility when utilizing Legislative Branch travel funds and to ensure that**  
8 **traveling Council Representatives are responsible.....; and**

9 **WHEREAS, the Legislative Rules Committee finds that until all outstanding balances are repaid**  
10 **that quarterly reports by the administration shall be reported to the full Legislative**  
11 **Council in an open session; and**

12 **WHEREAS, the Legislative Rules Committee recommends that expenditure reports be submitted**  
13 **until all outstanding balances are cleared.**

14 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that quarterly**  
15 **reports of the outstanding travel per diem for the Legislative Branch be submitted to**  
16 **the Full Legislative Council until all outstanding balances have been cleared.**

17 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup> Day of**  
18 **AUGUST, 2003 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**  
19 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (a) of**  
20 **Article VI of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18,**  
21 **1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March**  
22 **6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
