

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tabling the FY 2004 Projected Revenues in the Amount of \$44,164,113)

LEGISLATIVE ORDER NO. 03-376

1 **WHEREAS, the Budget and Finance Committee, Executive, Judiciary and Legislative reviewed the**
2 **revenue projection and available revenues for FY 04; and**

3 **WHEREAS, the Budget and Finance Committee did make a presentation to the council on the**
4 **revenue projections and available resources in the amount of \$44,164,113 to fund the**
5 **Nation's budget for FY 2004; and**

6 **WHEREAS, \$5,200,000 of the available funds represents amount owed to the Nation by its districts**
7 **and entities and that the majority of this debt owed to the Nation has been owed for**
8 **some time, but remains unpaid; and**

9 **WHEREAS, the council did hear the Chairwoman of the Nation's considerations and proposals.**


10 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby tables**
11 **any consideration of the FY 04 projected revenues until the September General**
12 **Session.**

13 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 22ND, Day of**
14 **AUGUST, 2003 at a meeting at which a quorum was present with a vote of 2,080.95 FOR; 83.15**
15 **AGAINST; 465.6 NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**
16 **Section 1 (a) of Article VI of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation**
17 **on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
18 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
