4		including a one-time per capita distribution of \$2,000 to each member of the Nation
5		enrolled on June 28, 1997 (the "Initial Per Capita Distribution"); and
6	WHEREAS,	pursuant to Resolution 97-451, the Legislative Council adopted an Initiative Funding and Council adopted an Council adopted adopt
7		and Implementation Plan (the ``FIP") which authorized the establish ment of set-aside
8		accounts for the Initial Per Capita Distribution and other Initiative measures, and set
9		certain conditions on the expenditure of funds from such accounts; and
10	WHEREAS,	by Resolution 97-478, the Legislative Council approved the transfer of funds from transfer of fun
11		Desert Diamond Savings Account to certain designated set-aside accounts
12		established at Bank of America Arizona, including the sum of \$41.5 million to set-
13		aside account no. 3030425-1067524 for the Initial Per Capita Distribution (the "Per
14		Capita Account"); and
15	WHEREAS,	three of the conditions to expenditure of the Per Capita Account specified in the FIP
16		are (1) approval by the Secretary of the Interior of a per capita distribution plan (the
17		"Revenue Allocation Plan") pursuant to the requirements of the Indian Gaming
18		Regulatory Act, 25 U.S.C. § 2710 (b) (3); (2) acceptance by the Legislative Council of a
19		Certification of Eligible Members submitted by the Enrollment Office and based upon and based upon and based upon are the enrollment Office are the enrollment

26		of the Bureau of Indian Affairs in accordance with authority delegated to the
27		Area Office by the Secretary of the Interior; and

The Tohono O'odham Legislative Council hereby accepts and approves the 24 Certification of Eligible Members, in the form attached hereto. 25 2. The Legislative Council authorizes (a) the transfer of the sum of \$76,000.00 from the Per Capita Account to the special checking account no. 252-350-324 26 27 established at Bank of America Arizona (the "Per Capita Checking Account"); and 28 (b) upon the joint signature of the Chairwoman and Vice Chairman of the Nation, 29 issuance of a check on the Per Capita Checking Account in the amount of (i) \$2,000
