**RESOLUTION NO. 03-384**

1 **WHEREAS, the Legislative Council did approve an Attorney Contract with the Law Firm of Shelley,**  
2 **Betha, Gillette & Clark by Resolution No. 02-050; and**

3 **WHEREAS, Human Resources Office has additional matters requiring legal counsel in Fiscal Year**  
4 **2003, which require amendment to the Attorney Contract in the form attached**  
5 **hereto; and**

6 **WHEREAS, the operating budget for the Human Resources Office (Account No. 01-1005-810) for**  
7 **fiscal year 2003 includes sufficient funds for the Attorney Contract; and**


8 **WHEREAS, the Domestic Affairs Committee and the Human Resources Development Committee**  
9 **recommends approval by the Legislative Council of an amendment to the Attorney**  
10 **Contract.**

11 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 12 **1. The Tohono O'odham Legislative Council hereby approves an amendment to the**  
13 **Attorney Contract with the Law Firm of Shelley, Bethea, Gillette & Clark to**  
14 **increase the amount of the contract by \$16,600 for a total budget of \$27,100 for FY**  
15 **2003.**
- 16 **2. Funding for the amendment to the Attorney Contract in fiscal year 2003 shall be**  
17 **provided under the operating budget of the Human Resources Office (Account No.**  
18 **01-1005-810).**
- 19 **3. The Chairwoman of the Nation is authorized and directed to execute the**  
20 **amendment to the Attorney Contract in the form attached hereto.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup>. Day**  
22 **of SEPTEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,171.1 FOR; 95.70**  
23 **AGAINST; 362.9 NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**  
24 **Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
25 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
27 **18, 1934 (48 Stat. 984).**
