RESOLUTION NO. 03-385

1 **WHEREAS, the Tohono O'odham Legislative Council has historically supported the Venito Garcia**
2 **Library and Archives, the library agency for the Tohono O'odham Nation; and**

3 **WHEREAS, the Tohono O'odham Legislative Council supports the Venito Garcia Library and**
4 **Archives' application for the 2003 Professional Assistance Grant of the Institute of**
5 **Museum and Library Services, Native American Library Services.**

6 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts the**
7 **grant donations for the Venito Garcia Library and Archives, and authorizes**
8 **acceptance and use of the grant in the amount of \$2,000.00.**

9 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day**
10 **of SEPTEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**
11 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Section**
12 **1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
13 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
14 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
15 **Stat. 984).**
