4 **\$1,235,197.96 for FY 2004; and**

5 **WHEREAS, the district budget committee did also review the proposed budget.**

6 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
7 **the Chukut Kuk District FY 2004 budget in the amount of \$1,235,197.96.**

8 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day**
9 **of SEPTEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,463.4 FOR; -0-**
10 **AGAINST; 166.3 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
11 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
12 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
13 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
14 **18, 1934 (48 Stat. 984).**


